It is for the entrant of the boat to decide whether the boat is seaworthy and/or fit to sail in any conditions that may be encountered. By going afloat, the entrant confirms that the boat is seaworthy and fit and that its crew is competent to sail in any conditions that may be encountered. Nothing done by the Organizing Authority can reduce the responsibility of the entrant nor will it make the Organizing Authority responsible for any loss, damage or personal injury, however the same may have occurred, as a result of the boat's participation at the event. The term "Organizing Authority" shall include any person helping to run and/or assist with the event and it includes, but is not limited, to Coleraine Yacht Club, the Race Committee, Principal Race Officer, trustees, rescue craft, sponsors, supporters and other companies and organizations officially involved with the event.

If any provision in this Disclaimer of Liability is deemed for any reason to be invalid, void or deleted, the remainder of it shall nevertheless remain in force.
